3. TURN IN REGISTRATION FORMS AND PAY ADMISSION.
4. PROCEED TO COMPETITION FLOOR WITH DIVISION SHEETS AND WRIST BANDS.

TEAM REQUIREMENTS

- OPEN TO ALL STYLES, SYSTEMS AND BELT COLORS.
- 90 SEC. MAXIMUM TIME PER FIGHT.
- 5 MIN. TIME LIMIT FOR SELF DEFENSE AND DEMONSTRATIONS.
- A TEAM EQUALS TWO OR MORE INDIVIDUALS. MUSIC IS ALLOWED FOR SELF DEFENSE & DEMONSTRATION.

- ALL FORMS & WEAPONS DIVISIONS REQUIRE 3 JUDGES
- LIGHT FACE CONTACT FOR ALL SPARRING DIVISIONS
- 2 OUT OF 3 JUDGES MUST VOTE THE POINT BEFORE AWARDED
- BLOOD IS NOT AN AUTOMATIC DISQUALIFICATION (PENDING JUDGE)
- ALL MATCHES ARE 2 MIN. OR 7 POINTS
- 1 POINT FOR HAND AND BODY KICKS
- 2 POINTS FOR HEAD KICKS
- NO SWEEPS OR TAKE DOWNS
- **MANDATORY SPARRING EQUIPMENT REQUIRED:** HANDS, FEET, HEADGEAR, MOUTHPIECE, AND GROIN CUPS FOR MALES
